At no circumstances Greedex.org verification can be considered as an endorsement or recommendation of the *Verified* company's services or products.

Verification Standard Requirements

1. Credibility

At Greedex.org, we define credible those companies which:

- have been operational for at least last 6 months,
- offer services/products to benefit its customers, users,
- are free from any legal actions which could directly prevent the company to offer services or products to its existing or future customers, clients, users.

2. Trustworthiness

Company's services or products must be clearly defined. Company must have all licenses or registrations if applicable to do particular business activities.

3. Transparency

Proofs of company's transparency include but are not limited to *company office address, legal name searchable in government business registry, registration date, number of employees, social media presence, third party listing presence, third party media mentions etc.*


4. Responsiveness

Company must have and maintain active customer support or contact page with up to date contact information Company must respond to its customers, clients, users in timely manner via email, phone or social media.

5. Honest advertising

While advertising its services company must follow federal, state and local advertising laws, avoid misleading customers by creating the false impression about its products or services, avoid advertising "get-rich quick" schemes, multi level marketing schemes, illegal financial products.

Verification Badge

The green *Verified* badge  on Greedex.org lets people know that the listing is authentic, met all our **Verification Standard Requirements** and [Submission Requirements](#) (explained further).

Currently all of the companies in the Directory are Verified.

Submission Requirements

Only the representative of the company can submit the information in the company listing form.

Representative must provide his/her name, position and email address which matches the domain of the company's website. The confirmation email will be sent to the email address provided to confirm the company's representative affiliation with the business.

Application Fee

Greedex.org charges non-refundable application fee of \$100 paid in equivalent of Bitcoin or Ethereum at the exchange rate at the time of payment in the payment section of the application.
