

## PRIVACY POLICY

### **Our priority is the safety of your information**

Protecting our customers' personal information is our priority. When providing our services and products, we do need to collect and hold personal information. This Privacy Policy addresses:

1. Why we collect personal information
2. What personal information we collect
3. What we do with that personal information
4. And how we protect personal information

### **Why we collect personal information**

We only use or disclose personal information for the purposes expressly disclosed to you, except as otherwise required by law. We will contact you to request direct consent before using or disclosing any of your information for materially different purposes.

This means that, for use other than those outlined individually below, additional consent will be obtained using legally sufficient methods. For example (depending on the laws of your local jurisdiction), you might be provided with a notice and the opportunity to opt-out before any personal information is disclosed.

In general terms, our collection, use and disclosure of personal information revolves around meeting the needs of our customers in providing our products and services, namely to:

- meet the operational needs of our accounts and services;
- collect billable invoices from you;
- inform you of any additional or related products or services that might interest you;
- manage our website to optimal performance;
- study and understand you and your needs;
- learn about our market to improve the user experience throughout all related products and services;
- process contact requests, queries, or job applications;
- comply with any regulatory and legal obligations, including but not limited to subpoenas or other court orders and warrants;
- contact you in response to comments or queries;
- monitor for and investigate suspicious activity;
- protect Sio2Labs's rights and privacy.

We reserve the right to collect personal information from visitors to our website as well as users who participate in contests or surveys, whether online or through other channels such as phone calls. This information may be used to communicate other services or products which might be of interest. We reserve the right to invite visitors to participate in additional market research and related activities.

If or when we were to propose buying or selling any assets, your information may be disclosed in an anonymized fashion with other customer information. This would only occur when disclosing information to a prospective buyer or seller. In the event of any such acquisition or merger you will be given notice if or when there is any such transfer of your information.

## **What personal information [Greedex.org](https://www.greedex.org) collects**

When you use our services or purchase our products, by applying, opening, or maintaining any account with us or agree to provide advisory services, we collect the following types of information:

Any personal information you provide online via forms or applications or through correspondence we have directly with you or with your representatives. This information includes but is not limited to: name, address, birth date, investment experience, risk tolerance, personal goals or objectives, transactions with us, account balance with us, trading activity, and general [Greedex.org](https://www.greedex.org) account history.

## **Where we store personal information**

Any personal information we collect will be stored in the United States as well as in other countries where the privacy laws may be different than those in your country of residence.

Some or all of your personal information may be held in countries other than your own whenever you provide personal information to third parties. You must acknowledge and understand that your personal information, thus, will be subject to local laws and protections for each jurisdiction.

For example, the United States government has certain legislation pertaining to the right to government entities to access your personal information, while this might not be true in another country where your information is stored. In any event that you have questions with respect to our servers or other third parties' servers where your personal information is stored, you can contact our Chief Privacy Officer at [cpo@greedex.org](mailto:cpo@greedex.org).

Any information that you provide online through any channel or device, including in discussions we have with you or your representatives, pertaining to information such as your name, address, birth date, investment experience, risk tolerance, personal investment goals and objectives, account balance, trading activity, and account history must be included in the above considerations.

## **How we protect the privacy and security of personal information**

We also support physical and procedural safeguards in addition to electronic safeguards to protect your personal information. For example, we place your information on the protected part of our website behind firewalls and other security technology to protect our network, systems, and all information thereon from external attacks. We thus require that you enter your unique username and password to access any account information.

Our servers, in addition to supporting other security features, use Transport Layer Security (or TLS) technologies in order to prevent any unauthorized access to personal information on customer accounts. Look for the padlock icon in your browser address bar to verify that the TLS feature is active.

Furthermore, any information you access through our website uses digital certification services in order to authenticate that you are making transactions directly through our site and not through a phishing site.

A limited number of third-party service providers as well as our employees have access to your personal information on a "need-to-know" basis in order to deliver our products and services. We regularly audit all operational business practices to ensure the protection of your information.

## **How to view personal information and correct inaccuracies**

As our customer you can access and update your personal information, where appropriate. You can use our website to make these updates by accessing your account through the secure platform to make changes quickly and easily. Or, you can email us directly to update your personal information by contacting our Chief Privacy Officer at [cpo@greedex.org](mailto:cpo@greedex.org).

All reasonable efforts will be employed to maintain your personal information in a complete and accurate form. If you become aware of any inaccurate information, whether entered erroneously, incompletely or if it is out of date, you can request a correction at any time.

In certain circumstances, such as when we do not have your personal information as a custodian of third-party data, you may be required to demonstrate that the information is inaccurate or incomplete before the information is updated. We may ask for additional personal information in order to confirm your identity.

#### **What to know about browser “cookies”**

Browser “cookies” are small transmissions of data sent from our server to your web browser which are then saved to your computer to create a “user profile” to enhance your website experience.

These cookies do not contain any personal information, rather track behaviors. There will be no personal information stored in cookie data.

You furthermore have control over all browser cookies. Most web browsers automatically notify you when there are cookies on your computer, and you can delete or correct cookie entries. If you delete or disable cookies, this might affect the operation of our website.

#### **What to know about the confidentiality of minors**

Our website is only for people over 21 years of age. We do not intentionally collect information for people below 21 years old. If we do find that a user younger than 21 has provided us with personal information, reasonable steps will be taken to remove any personal information about such user. Please contact us immediately if you believe we accidentally received personal information from any person under 21 years of age.
